Maritime firms' expired accreditation certificates get 1-year extension

- The Maritime Industry Authority has extended for one year the validity of expiring and expired accreditation certificates of maritime enterprises, including domestic shipping lines
- The extension follows the signing into law of Republic Act 11659 (amended Public Service Act), whose provisions effectively amended issuances related to domestic shipping and maritime enterprises
- The extension starts from April 7 and pending the crafting of RA 11659 implementing rules and regulations and subsequent amendment/peel of related MARINA circulars, whichever comes earlier

THE Maritime Industry Authority (MARINA) has extended for a year the validity of expiring and expired accreditation certificates it issued to domestic shipping

Globalport JV bags Tagbilaran port contract

- The joint venture of Globalport Terminals, Inc. and Globalport Ozamiz Terminal, Inc. won the 15-year terminal management contract for the baseport of Tagbilaran in Bohol
- The JV won for a proposed concession fee of P3.903 billion
- The contract covers management and operation of the cargo-handling, passenger, roll-on/roll-off, and other port-related services at the ports

Ozamiz Terminal, Inc. (GOTI) won the 15-year port terminal management contract for the baseport of Tagbilaran in Bohol.

The JV won for a proposed concession fee of P3.903 billion, according to PPA's notice of award.

In a resolution dated March 28, PPA's Bids and Awards Committee recommended the award of contract to Globalport JV, the highest bidder. The JV bested the bid of Mega Lifters Cargo Handling Corp. The other bidder Starlite Marine & Industrial Services Corp. failed to pass the technical bid during the bids

CNC adds Batangas, GenSan ports to expanded CP2 run

- Cheng Lie Navigation has added the Philippine ports of Batangas and General Santos as well as the Chinese port of Nansha to its CP2 Service
- Customers now have more port options when shipping cargoes in the Philippines and South China, the Singapore-based liner says
- CP2 provides a shuttle service between Hong Kong/South China ports and Philippine outports and connects Philippine outports directly with Nansha/Shekou/Hong Kong

SINGAPORE-BASED Cheng Lie Navigation Co., Ltd. (CNC) has expanded its CP2 Service, adding Batangas and General Santos in the Philippines and Nansha in China to the route.

The weekly service will give customers more port options when shipping their cargoes in the Philippines and South China, the intra-Asian shipping line said in a recent announcement.

The Batangas port call is at Asian Terminals Terminal (arriving Tuesday also leaving Tuesday) and General Santos, at the Makar Wharf (arriving Friday, leaving Saturday).

CP2's rotation is now Hong Kong - Shekou-Batangas- General Santos - Davao - Guangzhou - Hong Kong - Shekou- Subic Bay - Cebu - Cagayan de Oro

Strong cargo revenues power PAL 2021 income to P56.5B

- Philippine Airlines' total comprehensive income of P56.49 billion in 2021 reverses the P73-billion loss it suffered in 2020
- The airline reported a 6.2% revenue growth in 2021 mainly spurred by a 60% year-on-year increase in cargo revenue
- Operating expenses shrank 23.3% year-on-year due to lower costs from grounding of aircraft

PHILIPPINE Airlines reported today, April 5, a total comprehensive income of P56.49 billion in 2021, a turnaround from the P73 billion loss in 2020.

Revenue reached P58.70 billion, 6.2% higher than the P55.26 billion posted in 2020.

The growth in revenue came mainly from a significant increase in cargo revenue "as air cargo has been a vital partner in delivering essential goods since the COVID-19 pandemic", parent firm PAL Holdings Inc. said in a disclosure to the Philippine Stock Exchange.

Cargo revenue jumped 60% to P15.021 billion from P9.413 billion in 2020.

PAL director Lucio Tan III had earlier said the flag carrier pivoted to become a cargo-driven airline during the pandemic as passenger traffic dropped significantly due to government-imposed travel restrictions globally and locally to contain the COVID-19 pandemic.

PAL president and chief operating officer Stanley Ng had also said the airline will continue to develop its cargo business

and offer more hybrid flights and last-mile cargo deliveries this year. He said PAL will develop all-cargo markets and wean itself from dependence on passenger traffic as a single revenue source.

Revenue from ancillary services surged 61% last year to P6.398 billion from P3.98 billion in 2020.

Passenger revenue, on the other hand, declined 11% to P37.256 billion from P41.860 billion.

Operating expenses were reduced by 23.3% to P62.80 billion from P81.84 billion mainly due to lower costs related to the grounding of aircraft.

PAL voluntarily filed for bankruptcy with the United States Bankruptcy Court in New York in September 2021 to implement a restructuring plan that

will help it navigate and survive the COVID-19 crisis.

PAL emerged from the Chapter 11 restructuring last December after receiving unanimous support from its lenders, aircraft lessors, equipment manufacturers and service providers.

The restructuring plan provided for permanent balance sheet reductions from creditors, a 25% cut in fleet capacity, and improvement in the airline's critical operational agreements.

PAL's Manila hub performance is set to reach pre-COVID levels for domestic flights from April onwards, with 27 destinations and over 450 departures during the summer season. PAL will also build its Cebu hub to expand flights to 13 domestic routes and some flights to Japan.

Chelsea Logistics loss widens to P3.9B in 2021

- Chelsea Logistics' net loss widened 18% in 2021 due to non-recurring items that include sale of assets below book value
- Declines in the group's passenger, tanker and tugboat businesses shrank consolidated revenue by 4%
- Freight and logistics segments posted 30% and 41% higher revenues in 2021

CHELSEA Logistics and Infrastructure Holdings Corp. (CLC) reported a net loss of P3.905 billion in 2021, larger by 18% year-on-year than the P3.3 billion in 2020 due to non-recurring items that included sale of assets below their book value.

Excluding these one-time items, CLC's net loss would have actually narrowed by 18% year-on-year from P5.157 billion in 2020 to P4.253 billion in 2021, CLC said in a statement.

Consolidated revenue decreased 4% to P4.469 billion on the back of declines in the group's passenger, tanker and tugboat businesses. These setbacks were mitigated by strong growth in the freight and logistics segments.

The freight business continued to recover with a 30% y-o-y increase in revenue to P2.727 billion, already surpassing

the P2.688 billion revenue in 2019 before the COVID-19 pandemic and the first lockdown in March 2020.

Freight accounted for 61% of CLC's consolidated revenue, up from 45% in the previous year.

Revenues from the logistics business advanced 41% to P519 million. Logistics' share in the total revenue also grew to 12% in 2021 from 8% in 2020.

Travel restrictions

Travel restrictions implemented not only by the national government but also by local government units in areas where CLC's shipping subsidiaries make port calls continued to challenge the passenger business.

Restrictions in movement of petroleum products as well as lower demand from customers also hampered recovery of the tankering business.

CLC, however, noted signs of recovery, especially for passage, whose year-on-year revenue decline slowed down from 65% in 2020 to 42% in 2021, at

P293 million.

For 2021, the company was able to cut its operating losses by 17% to P2.001 billion.

"We remain very encouraged in seeing pockets of recovery in the industry. This is despite outside factors like the peaks in the number of active COVID-19 cases last year and the Omicron variant surge at the beginning of this year," said CLC president and chief executive officer

Chrissy Alfonsus Damuy.

"We are hopeful of a further recovery this year while we need to be careful of prices as they will certainly have a negative impact on our margins."

CLC subsidiaries include Chelsea Shipping Corp.; Trans-Asia Shipping Lines Inc.; Udena Investments B. V.; Starlite Ferries Inc.; Worklink Services Inc.; TASLI Services Inc., and The Supercat Fast Ferry Corp.

PH manufacturing grows for 11th straight month in Feb

- The Philippine manufacturing sector grew for the 11th consecutive month in February 2022, recording double-digit growth in both volume and value
- The Volume of Production Index rose at 84.3% while the Value of Production Index increased at 92.4%
- 19 of 22 industry divisions recorded positive growths led by manufacture of coke and refined petroleum products
- The average capacity utilization

rate for the sector rose to 69% from 68.3% in the previous month

THE Philippine manufacturing sector grew for the 11th consecutive month in February 2022, recording double-digit growth in both volume and value, according to the Philippine Statistics Authority (PSA).

The Volume of Production Index (VoPI) rose at an annual rate of 84.3% in February 2022, higher than the 17.1% growth in January 2022 and a reversal from

the -43.9% drop in February 2021, according to PSA's latest Monthly Integrated Survey of Selected Industries.

The Value of Production Index (VaPI) likewise increased with an annual growth rate of 92.4% in February 2022, from a slower annual rate of 21.8% in January 2022 and in contrast to the -47% decline in February 2021.

VoPI and VaPI started recording growth in April 2021 after 13 consecutive months of decline, an effect of COVID-19-related restrictions in the country that began March 2020 and dragged produc-

tion and sales indices for the sector.

The surge in VoPI was brought about by positive growth of 19 of the 22 industry divisions. Of these, the manufacture of coke and refined petroleum products was the major contributing factor with a three-digit annual growth rate of 748.9%. The three industry divisions that recorded decreases were led by manufacture of electrical equipment with -28.8% annual rate.

For VaPI, 19 industry divisions reported positive growths led by manufacture of coke and refined petroleum products, which posted an annual growth of 874.9%. Three industry divisions showed downturns in February, with manufacture of electrical equipment seeing the fastest decline of -26.2%.

Based on the survey's responding establishments, the average capacity utilization rate for the manufacturing sector in February was 69% from 68.3% in the previous month.

Almost all industry divisions reported capacity utilization rates of more than 50% except for manufacture of wood, bamboo, cane, rattan articles, and related products (48.7%). Among these, the top three industry divisions were manufacture of furniture (84.1%), manufacture of other non-metallic mineral products (80.5%), and manufacture of electrical equipment (76.8%).

A fifth or 20% of the responding establishments operated at full capacity (90% to 100%), 36.8% at 70% to 89% capacity, and 43.2% below 70% capacity.

BOC fires 2 employees, probes more than 250 others in graft crackdown

- BOC issued 32 show cause orders and investigated 250 personnel in a crackdown on graft in the first quarter
- Two BOC employees were sacked, two others were suspended, one was reprimanded, 85 were relieved, and nine were reshuffled or reassigned due to irregular and unlawful activities
- BOC also filed one administrative case against an employee before the bureau's Legal Service and endorsed six cases to the National Bureau of Investigation

FROM January to March 2022, the Bureau of Customs (BOC) fired two employees, suspended two others, reprimanded one, relieved 85, and reshuffled or moved nine to various offices and ports due to irregular and unlawful activities, the agency said in a statement.

The Customs Intelligence and Investigation Service also conducted 250 personnel investigations, which resulted in the filing of one administrative case before BOC's Legal Service and six cases at the National Bureau of Investigation.

The latest actions followed a crackdown on irregular and unlawful activities in 2021 during which BOC issued 1,153 show-cause orders that led to three employee dismissals, 17 suspensions, six reprimands and 19 being relieved, while 721 were reshuffled or transferred to various offices and ports.

With its numerous initiatives to boost the level of integrity within the organization, BOC said "evident developments were indeed attained by the agency as verified by the improved ratings from the general public and agency stakeholders..."

In the Awareness, Institutional Trust, and Satisfaction Survey conducted by the Philippine Statistics & Research Center in 2021, BOC's trust rating rose to 94% from 30% in 2020, the agency said.

To ensure reforms will be realized, BOC said its units and offices continue to undertake the ISO 9001:2015 Quality Management System certification. As of March 2022, 12 BOC offices comprising ports, subports, and customer care centers had obtained ISO 9001:2015 QMS certification while the rest are in various stages of compliance.

opening on March 14.

GTI and its subsidiaries, which include GOTI, are engaged in port terminal management operations. Its network includes the ports of Matnog, Tacloban, Nasipit, Pulupandan, Iligan, Ozamiz, Surigao and Zamboanga, which they won the biddings for under PPA's Port Terminal Management Regulatory Framework (PTMRF).

The Tagbilaran contract covers management and operation of the cargo-handling, passenger, roll-on/roll-off (RoRo), and other port-related services at the ports. It involves stevedoring services, bagging services, container terminal management, passenger terminal management, portage services, storage management, waste and shore reception facility management, water distribution services, weighbridge facility, and ancillary and other related services.

The bidding was conducted through

open competitive bidding procedures using non-discretionary pass/fail criterion as specified in PPA Administrative Order (AO) No. 12-2018, as amended.

AO 12-2018 provides guidelines for selecting and awarding contracts under PPA's PTMRF, which outlines new rules for terminal management contracts.

PTMRF, provided under AO 03-2016, seeks to provide higher quality port service by promoting private sector participation. Under this framework, investments in ports are to be categorized into six tiers, ranging from a fully private concession to a fully PPA-managed port, to make it easier to determine investment arrangements of a port.

PPA started bidding out port contracts under the PTMRF in 2020.

Tagbilaran port falls under Tier 3, which means the contractor's investments

include above-ground fixtures and semi-fixtures, and mobile handling equipment.

The baseport of Tagbilaran handles domestic and foreign cargoes, recording 1.759 million metric tons (MT) in 2021 slightly less than the 2020 volume of 1.874 million MT. Last year, PPA inaugurated a newly constructed second passenger terminal building at the port, expanding the facility's capacity to 1,110 passengers. The port sustained significant structural damage from a strong earthquake in 2013.

PPA earlier also opened bidding for


the port terminal management contracts of Puerto Princesa, Ormoc, Tabaco, Legazpi, Zamboanga, Iligan, Ozamiz, Calapan, Tacloban, Nasipit, Matnog, Fort San Pedro, Pulupandan, Surigao, Tagbilaran, Masao, Pagadian and Pasig River ports.

Of these, PPA has already awarded the contracts for the ports of Iligan, Ozamiz, Zamboanga, Tacloban, Nasipit, Matnog, Pulupandan, Surigao, Ormoc, Puerto Princesa, Calapan, Legazpi, Tabaco and Masao. — **Roumina Pablo**

lines and maritime enterprises.

MARINA Advisory (MA) No. 2022-26 was issued following the signing into law of Republic Act No. 11659 (amendments to the Public Service Act or PSA), which effectively amends MARINA circulars and other issuances related to domestic shipping, including those on accreditation of domestic shipping operators/firms/entities and maritime enterprises.

The one-year extension starts from the issuance of MARINA Advisory (MA) No. 2022-26 on April 7 and pending the

crafting of implementing rules and regulations of RA 11659 and the subsequent amendment/repeal of related MARINA circulars, whichever comes first.

It covers accreditation certificates issued pursuant to MC No. 186, MC DS-2020-02, and MC 2006-03. MC 186 series of 2003 provides rules on accreditation of maritime enterprises but this was repealed by MC DS-2020-02 issued in 2020. MC 2006-03, meanwhile, provides revised guidelines on accreditation of domestic shipping enterprises or entities.

Maritime enterprises include a com-

pany or business undertaking which may include ship management; ship agency; multimodal transport operation and any other similar enterprise whose activities consist of representing within the Philippines, as an agent, the business interests of one or more shipping lines or shipping companies. It also includes ship husbanding; ship chandling; manning; companies engaged in importation and trading of accessory boats, recreational crafts, and marine spare parts; and other similar enterprises.

RA 11659, signed by President

Rodrigo Duterte on March 21, amends the 85-year-old PSA and relaxes foreign ownership in certain industries, including domestic shipping, airlines and telecommunications.

The measure removes the 40% foreign investment limitation on sectors such as telecommunications, railways, shipping, airlines and airports.

Under the law the definition of "public utilities" and "public service" was delineated. Identified as public utilities are distribution and transmission of electricity; petroleum and petroleum products pipeline transmission systems; water pipeline distribution systems and waste water pipeline systems, including sewerage pipeline systems; seaports; and public utility vehicles (including trucks).

Any industry not on the list will be exempt from the 60-40 ownership limitation under the Constitution and may accept up to 100% foreign investments.

 together with partners from the maritime sector, are working closely to further intensify our efforts to ensure the safety, security, order and convenience of the travelling public," CPA general manager Leonilo Miole said.

Consistent with guidelines from the Maritime Industry Authority, CPA will strictly impose the mandatory wearing of face mask, temperature check of passengers upon entry into port passenger terminal facilities, ban from talking and taking unnecessary phone calls, and observance of social distancing, especially in common areas such as canteens,

lounges, open decks, comfort rooms and the like.

Cebu City, Lapu-Lapu City and Mandaue City are at Level 1 alert from April 1 to 16 while the rest of Cebu province is at Level 2, which, among other restrictions, prohibit overcrowding in public areas.

Considering some port facilities and passenger terminal buildings are still undergoing repair and rehabilitation after sustaining significant damage last year from typhoon Odette, CPA is encouraging passengers to strictly observe a one-meter distance while queuing at the passenger terminal during boarding and disembarkation.

"With the ongoing repair and rehabilitation of some of our port facilities, we still have limited areas to accommodate a large number of passengers. Therefore, we appeal to our travelling public not to go to ports without confirmed travel booking to avoid overcrowding," Miole said.

Only passengers with boat tickets and valid identification cards will be allowed entry into the port at least two hours from the scheduled departure time. CPA will also strictly impose the "No ticket, No ID, No Entry Policy".

Miole reminded the public not to patronize ticket scalping as it is illegal. He advised travellers to book their tickets in advance to avoid heavy queuing outside the port area, where most ticketing outlets

are located.

Malasakit Help Desks and first-aid stations will be activated at passenger terminals to attend to various passenger concerns. Port management offices have been directed to ensure all booths/counters/centers serving passengers are properly manned during operating hours.

Direct boarding of passengers will be allowed as necessary to avoid crowding, inconvenience, or delay of the vessel's departure provided security, safety, and health protocols are observed.

For the duration of Oplan Biyaheng Ayos, CPA will deploy additional port police officers at ports with high passenger traffic to enforce port safety and security protocols.

Fueling Our Future Supply Chains

the UAE and Oman, specifically. The rest comes from Brunei, our neighbors to the south.

THE Department of Energy's latest figures, released last year, state that we do not import crude oil from Russia. 92% of our crude oil imports, in fact, come from the Middle East - Saudi Arabia,

However, we only imported roughly 1.2 billion liters of crude oil for the twelve months ending in June 2021. In comparison, we imported roughly 10 billion liters of processed petroleum products in the same period of time. Inevitable, given that we only have one oil refinery in the country, Petron's facilities in Bataan. (Shell had a refinery, but is in the process of converting it to an import terminal in light of COVID-19 disruptions.)

Most of the petroleum products we import consist of the energy sources our supply chains heavily rely on: diesel (41.5%), gasoline (25.8%) and LPG

(13.5%). We mostly source them from China and our ASEAN neighbors. That said, our suppliers are likely sourcing their products from countries outside our traditional sources of crude oil, including Russia and Ukraine.

In any case, this makes the Philippines extremely susceptible to shocks in the oil market. We may not have direct exposure to Russia, the world's second largest producer of oil, but economic sanctions imposed in response to its invasion of Ukraine have jacked up prices in every oil market. Long-term supply continues to be a concern as the conflict rages on, and will continue to do so once it ends; sanctions will likely remain in place in the aftermath, when the conversation shifts towards war crimes committed by Russian forces. It's no surprise that prices at our pumps jumped to such levels in the open-

ing weeks of the war - and while they have stabilized as of this writing, there's really little indication that these prices will go back to a more affordable level.

Our supply chains rely heavily on fuel for transporting goods, which means we are also heavily susceptible to these spikes. As we have seen in recent years, there's only so much we can do to minimize costs before passing them on to the consumer. Transport rates will definitely go up in the coming months, particularly as contracts are renegotiated - and that will translate to higher prices in your shelves, physical or virtual.

There's one more thing to ponder upon as we consider our increasing transport costs. Last week the Intergovernmental Panel on Climate Change released the final part of its latest re-

port. It says it is "almost inevitable" we will breach our commitments set by the Kyoto protocol, of limiting global heating to 1.5C above pre-industrial levels. It also says efforts to reduce the global economy's carbon footprint are lagging behind, and that countries must significantly step up efforts in this decade if the overshoot is to be reversible. These include advanced technologies like carbon capture and storage, as well as lifestyle changes across the board, but a significant move would be to drastically reduce reliance on fossil fuels including coal and, more appropriately for our supply chains, petroleum. It's especially important for the Philippines, a country that is highly susceptible to the catastrophic effects of climate change.

One obvious path is to accelerate the adoption of electric vehicles across our land transport networks. It's already happening here: Mober, for one, is expanding its EV fleet, aiming to have a hundred such vans and trucks by the end of this decade. But they're just one player in a diverse transport landscape that includes traditional truckers and emerging last mile providers. If we are to truly accomplish what the IPCC report challenges us to do, everyone has to do their part, and fast.

But it is going to be a monumental undertaking. The Electric Vehicle Industry Development Act recently passed Congress and is just awaiting the president's signature - but while it encourages investment in the infrastructure supporting EVs (like charging stations), it doesn't exactly encourage individuals and companies from purchasing the vehicles themselves. AutoIndustriya.com reports that the law does not exempt EVs from import duties and other taxes, supposedly due to opposition from the Department of Finance.

This means buying EVs will be prohibi-

tively expensive. Such passenger vehicles already begin at the PHP 2 million mark. What more cargo EVs? It's already difficult for truckers to adapt to evolving requirements for their vehicles, particularly on fuel efficiency, as the cost of acquiring these vehicles remains high. They risk being left behind if we do start the shift to EVs - not without subsidies and other forms of financial support to help them along the way.

Of course, it isn't only down to what vehicles we use. For one, we also need further investment in renewable energies, such as solar and wind power, to make them more affordable. This way we can both minimize our carbon footprint and keep our supply chains competitive. This way we can withstand the shocks we are currently seeing in the oil market. This way we can pass on long-term cost savings to our end customers.
